Eligibility

All registered degree seeking undergraduate students taking 12 or more credit hours (or considered full-time) and Non-Supported Graduate students taking 9 (nine) or more credit hours (or considered full-time) are eligible to enroll in this insurance plan on a voluntary basis. Credit hour requirement can be met by a combination of online and on campus credit hours, not to exceed 50% online.

Eligible Dependents, including Domestic Partners of enrolled students may participate in this plan on a voluntary basis.
